EXPLANATORY NOTE

WHEREAS, local government units are mandated, under the Local Government Code of 1991, to provide basic services and facilities that are intended primarily to serve the needs of the residents of the municipality, such as health facilities;

WHEREAS, it is one of the major thrusts of the present administration to establish and operate a hemodialysis and diagnostic center to cater to the needs of local patients most especially the indigents who cannot afford the costly hemodialysis sessions and the incidental expenses such as transporting the patient from Bamban to hospitals in Tarlac or Pampanga and back;

WHEREAS, out of this desire to help the indigents and sick, the present municipal administration has appropriated funds to construct the hemodialysis and diagnostic centers in DapDap Resettlement Site and to procure the hemodialysis machines;

WHEREAS, this Body deemed that the said health facilities be named in honor of the late spouses – the former Tarlac Governor Eduardo C. Cojuangco Sr. and Doña Josephine M. Cojuangco scions of the Cojuangco family in the Province of Tarlac who are well known for their philanthropic deeds and humanitarian endeavors in the development and building of communities that benefitted many Tarlaqueños most especially the indigents;

NOW THEREFORE on motion of Councilor Ernesto P. Go, unanimously seconded by the Body:
