APPROPRIATION ORDINANCE NO. 01-2020

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1, FY 2020 INVOLVING AN AMOUNT OF THIRTY NINE MILLION NINE HUNDRED EIGHTY ONE THOUSAND ONE HUNDRED NINETY SEVEN PESOS AND SIXTY THREE CENTAVOS (PHP39,981,197.63) FOR FUNDING OF VARIOUS PROJECTS/UNDERTAKINGS IN THE MUNICIPALITY INTENDED TO COMBAT COVID-19 AND TO PROVIDE BASIC SERVICES TO AFFECTED LOCAL POPULATION DURING THE ENHANCED COMMUNITY QUARANTINE (ECQ)

Be it enacted by the Sangguniang Bayan in session assembled, that:

Section 1. The Supplemental Budget No. 01 of the Municipality for Fiscal Year 2020 in the total amount of **Thirty Nine Million Nine Hundred Eighty One Thousand One Hundred Ninety Seven Pesos and Sixty Three Centavos (Php39,981,197.63.00)** intended for funding of various projects/undertakings in the Municipality most especially those intended to combat or eliminate the threat of COVID-19 including basic services to affected local population during the Enhanced Community Quarantine (ECQ), is hereby **APPROVED**.

Section 2. The budget document consisting of the following are incorporated herein and made an integral part of this appropriation ordinance:

1. Letter/budget message of Mayor Jose Antonio T. Feliciano dated March 31, 2020 and
2. Statement of Funds/Supplemental Appropriation dated March 31, 2020

Section 3. **Sources and use of funds.** The sources of funds and the intended use hereof are indicated in the attached Statement of Fund.

Section 4. **Effectivity.** This appropriation ordinance shall take effect upon its approval by the Municipal Mayor.
