MUNICIPAL ORDINANCE NO. 68-2020

AN ORDINANCE CREATING TWO (2) MEAT INSPECTOR (SG-8) POSITIONS IN THE PLANTILLA OF PERSONNEL UNDER THE MUNICIPAL AGRICULTURE OFFICE, AND PROVIDING FOR THEIR QUALIFICATIONS, DUTIES AND RESPONSIBILITIES

WHEREAS, Municipal Ordinance No. 64-2020 otherwise known as the Local Meat Inspection Code of the Municipality of Bamban mandates, among others, the creation and establishment of a Municipal Meat Inspection Service (MMIS) as a regulatory body/unit in meat safety and whereby certain personnel are needed to carry out specific tasks in pursuance of its objectives;

WHEREAS, among these required MMIS personnel are Meat Inspectors who are tasked to perform ante and post mortem inspection on animals during slaughter as well as other duties and responsibilities to ensure that slaughtered meat both in government-owned and privately run abattoirs is fit for public consumption;

WHEREAS, the positions sought to be created are included in the approved Human Resource Plan of the Municipal Government/Annual Investment Plan 2021;

NOW THEREFORE, acting favorably on the letter/ request dated October 28, 2020 of the Municipal Mayor on the subject, be it enacted by the Sangguniang Bayan in session assembled, that:

Section 1. Two (2) positions of Meat Inspector with Salary Grade 8 are hereby created in the Plantilla of Personnel of the Municipal Government to be assigned under the Municipal Agriculture Office.

Section 2. **Qualifications.** The positions shall have the following qualifications:

1. Completion of at least two (2) years studies in college;
2. One (1) year relevant experience;
3. At least Four (4) hours training in Basic Meat Inspection (BMIT);
4. CSC Sub-Professional (1st level eligibility);
5. Must be a bona fide resident of this Municipality
6. Must be physically fit

Section 3. **Duties and Responsibilities of the Meat Inspector (MI).** The MI shall have the following duties and responsibilities:






1. Inspect relevant documents of animals presented for slaughter;
2. Conduct ante-mortem inspection of animals being brought inside the slaughter house for butchery and perform post-mortem examination of animal carcasses and their offal intended for public consumption;
3. Supervise the maintenance of adequate sanitation of the slaughterhouse and its premises; and
4. Perform other related duties as may be assigned from time to time

Section 4. **Funding requirement.** The funding for the said positions shall be included in the AIP and Annual Budget 2021.

Section 5. **Effectivity.** This ordinance shall take effect upon approval of the Municipal Mayor.







