

EXECUTIVE ORDER NO. ____ Series 2014

AN ORDER ESTABLISHING THE ANTI-DRUG ABUSE COUNCIL OF THE MUNICIPALITY OF BAMBAN

WHEREAS, under Regional Memorandum Circular No. 2009-01 of the Department of Interior and Local Government, all levels of local governments are mandated to create and reorganize, an Anti-Drug Abuse Councils (ADACs) in support of the continuing campaign of the government in the fight against illegal drugs.

WHEREAS, under Article II, Section 13 of the 1987 Philippine Constitution, the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth patriotism and nationalism and encourage their involvement in public and civic affairs.

WHEREAS, it is the duty of the Municipality of Bamban to protect its citizens, especially the youth, against harmful substances and eliminate the proliferation of these substances.

WHEREAS, it is the desire of the Municipality of Bamban to be a partner of the national government in its continuing campaign in the fight against illegal drugs.

NOW THEREFORE, I, JOSE ANTONIO T. FELICIANO, Municipal Mayor, by virtue of the powers vested in me under existing laws, promulgate an Order Establishing The Anti-Drug Abuse Council (ACDAC).

Section 1. This Order shall be known and cited as the Anti-Drug Abuse Council Order.

Section 2. It is hereby created and established the Anti-Drug Abuse Council to be composed as follows:

Section 3. The Functions of the Anti-Drug Abuse Council shall be as follows:

1. Serve as a focal point through which various organization and individuals work together cooperatively on planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for coordination of existing services and programs and those which might be developed in the immediate future;
3. Provide a mechanism to obtain funds, volunteer facilities and technical expertise.

This Executive Order takes effect immediately and will remain valid until rescinded in writing. Done this 31st of March 2014 at Bamban, Tarlac
