

EXECUTIVE ORDER 21 Series of 2014
REVISING THE COMPOSITION OF MARKET AUTHORITY OF BAMBAN PUBLIC MARKET

WHEREAS, Municipal Ordinance No. 4 Series of 2006, an ordinance enacting the Public Market Code of the Municipality of Bamban;

WHEREAS, this Code shall apply to govern the administration and operation of government owned and/or operated of any kind in the imposition and collection of market rentals and other fees for the occupancy of any part thereof.

WHEREAS, in order to obtain the objectives expressed in this Code, creation of a body which shall be called "MARKET AUTHORITY" is deemed necessary.

NOW THEREFORE, I, JOSE ANTONIO T. FELICIANO, Municipal Mayor, by virtue of the powers vested in me under existing laws, promulgate an Order Revising the Composition of Bamban Market Authority.

Section 1. This Order shall be known and cited as the Market Authority of Bamban Public Market

Section 2. It is hereby revised and to be composed as follows:

Section 3. Powers and Functions

1. Prepare and/or approve strategic development and action plans to ensure that market is fully develop and truly serving the general public.
2. Formulate policies, rules and guidelines for market operation and administration, in consultation with the duly organized Market Vendors Association.
3. Conduct periodic review of market operation.
4. Coordinate with the Budget Officer in the preparation of budget for the market operation
5. Adjudicate market stall to qualified parties.
6. Lead and settle grievance arising out of market operation.
7. Determine and recommend to the Sangguniang Bayan the market rates and fees at levels in order to render market operation that is economically viable.

Section 4. Meetings

The Market Authority shall have its regular meeting every 3rd Saturday of the Month. However, the Municipal Mayor may call a Special Meeting anytime when needed.

This Executive Order takes effect immediately and will remain valid until rescinded in writing.
