**RECONSTITUTING THE LOCAL SCHOOL BOARD**

**WHEREAS**, Section 98 of the 1991 Local Government Code, there shall be established in every province, city or municipality a provincial, city or municipal school board;

**WHEREAS**, with the recent reshuffling of School head, there is a need to reconstitute the Local School Board;

**NOW THEREFORE, I, JOSE ANTONIO T. FELICIANO**, Municipal Mayor of Bamban, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Local School Board of this Municipality

**Section 2. FUNCTION OF LOCAL SCHOOL BOARDS:**

1. Determine in accordance with the criteria set by the Department of Education, Culture and Sports, the annual supplementary budgetary needs for the operation and maintenance of public schools within the municipality and supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue as this Code and other laws or ordinances may provide;
2. Authorize the Municipal Treasurer to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with existing rules and regulations;
3. Serve as an advisory Committee to the Sangguniang concerned on educational matters such as, but not limited to the necessity for and uses of local appropriations for education purposes; and
4. Recommend changes in the name of public schools within the territorial jurisdiction of local government unit for enactment by the Sangguniang concerned.

This Executive Orders takes effect immediately and will remain valid until rescinded in writing.
