**EXECUTIVE ORDER NO. 12 Series of 2021**

**RE-ORGANIZATION OF THE LOCAL COMMITTEE ON ANTI-TRAFFICKING  
AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN**

**WHEREAS**, Joint Memorandum Circular No. 2010-01 mandates the creation of the Local Committee on Anti-trafficking and Violence Against Women and their children (LCAT-VAWC) at the Provincial and City/Municipal Level;

**WHEREAS**, the general purpose of creating the LCAT-VAWC is to establish and strengthen local structure that will collaboratively address Trafficking and Violence against Women and their Children.

**NOW THEREFORE, I JOSE ANTONIO T. FELICIANO**, Municipal Mayor, Municipality of Bamban, Tarlac, by virtue of the powers vested in me by law, do hereby re-organize the composition of the Local committee on Anti-Trafficking and Violence Against Women and Their Children.

**Section 1: Composition.** The LCAT-VAWC shall be composed of the following:

**Section 2: Functions:** LCAT-VAWC shall have the following functions:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence (enact local ordinance and resolution)
2. Create and establish systems on surveillance, investigation and rescue to ensure effective and efficient coordination.
3. Undertake information, education and advocacy campaign against trafficking in persons and VAWC.
4. Monitor and oversee the strict implementation of RA9208, RA 9262 and other related laws for the protection of women and children and of the LCAT-VAWC national plans of action.
5. Implement the programs and activities as stated in the National Plan of Action.




