EXECUTIVE ORDER NO. 13 SERIES OF 2021

**RE-ORGANIZATION OF LOCAL AIDS COUNCIL OF
THE MUNICIPALITY OF BAMBAN**

WHEREAS, Section 16, RA 7160 “General Welfare” states that every Local Government Unit shall exercise the powers expressly granted to them for the general welfare of their inhabitants like in the promotion of health and safety, preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 17, par. A.2. iii, RA 7160, “Basic Service” states that it shall provide health services, which include the implementation of programs and projects on a communicable and non communicable disease control services, access to secondary and tertiary health services; purchase of medicines, medical supplies, and equipment needed to carry out the services herein enumerated;

WHEREAS, the disease, Human Immune Deficiency Virus/Acquired Immune Deficiency Syndrome (HIV/AIDS) recognizes no territorial social, political and economic boundaries for which there is no known cure;

WHEREAS, in support to the prevention and control of HIV/AIDS, RA 8504, entitled, The Philippine AIDS Prevention and Control Act of 1998” was enacted to counter the threat of HIV/AIDS epidemic by promulgating related necessary policies and strategies and to monitor the implementation of this Act down to the local level;

WHEREAS, Local Government Units as front liners in the delivery of basic services shall also create an organization which aims to prevent, mitigate and eradicate the conditions that fuel the spread of HIV/AIDS;

NOW THEREFORE, I, JOSE ANTONIO T. FELICIANO, Municipal Mayor of Bamban, Tarlac by the powers vested in me by law, do hereby order:

SECTION 1. COMPOSITION OF THE LOCAL AIDS COUNCIL. The composition of the Local AIDS Council are the following:


SECTION II. FUNCTIONS AND DUTIES OF THE LOCAL AIDS COUNCIL. The Council shall be the central Advisory, Planning and Policy-Making Body for the comprehensive and integrated HIV/AIDS prevention and control program of the Municipality of Bamban.

The Council shall perform the following:

1. Formulate policies and strategies for the prevention and control of HIV/AIDS and STD like conduct of public awareness and education;
2. Prepare/develop HIV/AIDS prevention and control program and monitor its implementation;
3. Identify and prepare remedies to problems in program implementation and coordination and enhance local multi-sector response to HIV/AIDS concerns;
4. Propose related ordinances resolutions for approval of the sanggunian;
5. Recommend to the office of the Municipal Mayor the closure of any establishment found to be violating the provisions of pertinent laws and ordinances; and
6. Coordinate and cooperate with national government and other organizations regarding data collection, research and treatment modalities concerning HIV/AIDS.

This Executive Order takes effect immediately and will remain valid until rescinded in writing.
