EXECUTIVE ORDER NO. 14 Series 2021

**REVISING THE COMPOSITION OF MUNICIPAL TRICYCLE FRANCHISING
REGULATORY BOARD (MTRFB)**

WHEREAS, there is a need to reconstitute the composition of Municipal Tricycle Franchising Regulatory Board in view of the change in LGU administration.

WHEREAS, upon the dilution of the power to regulate and issue franchise to tricycles from the Land Transportation Authority to the local government units, various regulations, ordinances and policies pertaining to the operation of tricycles for hire for have been enacted or passed by the Sangguniang Bayan of Bamban to make orderly the operation of tricycles for hire within its territorial jurisdiction.

WHEREAS, the Sangguniang Bayan has observed, however that these issuances have not been properly implemented or complied with by all concerned and there now exists a necessity to amend the issuances and toward this end has enacted Special Ordinance No. 22-2012

WHEREAS, said Special Ordinance mandates the creation of a Municipal Tricycle Franchising Regulatory Board (MTRFB) whose membership and functions have been expressly defined therein.

NOW, THEREFORE, I JOSE ANTONIO T. FELICIANO, Municipal Mayor, by the virtue of the power vested on me by law do hereby create the Local Municipal Tricycle Franchising Regulatory Board in the municipality of Bamban, Tarlac and enjoining all concerned their support and cooperation.




DUTIES AND RESPONSIBILITIES

1. Supervise the franchising and regulate the operation of all public utility tricycle throughout the municipality.
2. Recognize and approve application for establishment of tricycle association terminals subject to requirements under Section 8 of Municipal Ordinance No. 1-2012
3. Abide the laws, rules, and regulations in connection with the issuance of franchises to public utility tricycles.
4. Receive, review, accept/deny applications for issuance of franchise and recommend the approval or disapproval of the same.
5. To inspect and determine the road worthiness of the public utility tricycle based on the standards, specifications and designs set forth in any law, ordinance, policy and guideline.
6. To post approved applications for franchises at identified areas and conspicuous places.
7. To maintain computerized database and other records pertaining to operation and issuance of franchise to public utility tricycles within the municipality.
8. To accredit fabricators/manufacturers of side cars to be used as public utility tricycle.
9. To recommend to the Sangguniang Bayan of this municipality reasonable fares and fees.
10. To hold regular meeting once a month or quarterly at a time or day as determined by the board
11. To do other MTFRB related functions that are inherent necessary for the smooth and effective delivery of franchising services.
