**EXECUTIVE ORDER NO. 56**  
**Series of 2021**

**AN ORDER FOR THE TEMPORARY CLOSURE OF ALL ESTABLISHMENTS  
DURING SUNDAYS, TO COMBAT THE INCREASE OF COVID-19 POSITIVE  
CASES IN BAMBAN EFFECTIVE September 12-30, 2021**

**WHEREAS**, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, on September 16, 2020, the President issued Proclamation No. 1021 (s.2020) extending the period of the State of Calamity throughout the Philippines until September 21, 2021;

**WHEREAS**, the Department of Health (DOH), the University of the Philippines-Philippine Genome Center (UP-PGC), and the University of the Philippines-National Institutes of Health (UP-NIH) bio surveillance have detected B.1.1.7 (Alpha), B.1.351 (Beta), and P.1 (Gamma) variants of SARS-CoV-2 in the Philippines. The DOH, UP-PGH, and UP-NIH have likewise confirmed the presence of the B.1.617 (Delta) variant that was first detected in India;

**WHEREAS**, despite of efforts and preventive measures, as of August 17, 2021 there was an increase or surge in number of COVID-19 positive cases in Bamban;

**WHEREAS**, the continued implementation of proactive measures and restrictions must be put in place to slow down the surge in COVID-19 cases, stop further spread of variants, buy time for the health system to cope, and to protect more lives.

**WHEREAS**, in accordance with the General Welfare Clause of R.A No 7160, otherwise known as the Local Government Code of 1991, for efficient and effective governance, the Municipal Government of Bamban shall enforce all laws, orders and ordinances relative to the governance of the Municipality.

**NOW THEREFORE, I, JOSE ANTONIO T. FELICIANO**, Municipal Mayor of Bamban, Tarlac by virtue of the power vested in me by the Constitution and law, do hereby order FOR THE TEMPORARY CLOSURE OF ALL ESTABLISHMENTS except Pharmacies, TO COMBAT THE INCREASE OF COVID-19 POSITIVE CASES IN BAMBAN, effective September 12-30, 2021

**SECTION 1. TEMPORARY CLOSURE OF ALL ESTABLISHMENT on SUNDAYS.**

All establishments such as but not limited to the following, are ordered to CLOSE/ STOP OPERATIONS DURING SUNDAYS, except PHARMACIES. Pharmacies will remain open even on Sundays.

**SECTION 2. IMPLEMENTATION**

**TO ALL PUNONG BARANGAYS**

- All Punong Barangay together with their councils and BPATS are hereby advised to apprehend possible violators of this Order
  - a. A written report supported with photos must be prepared in relation to any violations incurred

**TO THE CHIEF OF POLICE OF BAMBAN PNP**

- a. Ensure the implementation of this Executive Order in close coordination with all concerned department and barangays;
- b. Apprehend all violators of this Order

**Section 3. Repealing Clause.** All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

**Section 4. Separability Clause.** Any part of this Order that is declared null and void shall not have any effect on the entirety of the Order.

**Effectivity.** This Executive Order shall take effect immediately, all subject to monitoring, assessment and review and shall remain in force unless hereafter revoked.
