### RESOLUTION NO. 010, SERIES OF 2014

EXTENDING THE DEADLINE IN THE PAYMENT OF BUSINESS PERMIT/TAXES  
FROM JANUARY 20, 2014 TO FEBRUARY 20, 2014

WHEREAS, local transport groups, vendors and owners of many commercial establishments in the municipality have conveyed their request for an extension of the deadline in the payment of business permits/taxes citing reasons as ample time needed to produce the documentary requirements and financial difficulties as well;

WHEREAS, the 2004 Revised Revenue Code of the Municipality provides that the due date for the payment of taxes for each quarter is on or before the twentieth (20<sup>th</sup>) day of the subsequent quarter, if the taxpayer prefers to pay the tax on a quarterly basis;

WHEREAS, Sec. 2c.03, Article C of the same Code and Sec 167 of RA 7160 stipulates that *"The Sangguniang Bayan concerned, may, for a justifiable reason or cause, extend the time for payment of such taxes, fees or charges without surcharges or penalties, but only for a period not exceeding six months"*;

NOW THEREFORE, on motion of Councilor Ernesto P. Go duly seconded by Councilor July A. Vitug:

BE IT RESOLVED, that acting in the interest of the local transport groups, market vendors and all other business establishments in the Municipality, this Body hereby extend the deadline in the payment of business permits/taxes from January 20, 2014 to February 20, 2014.

RESOLVED, that all owners of business establishments shall be strictly required to display conspicuously the Mayor's Permit issued them.
