RESOLUTION NO. 039, SERIES OF 2014

REMINDING THE HONORABLE MAYOR ABOUT THE INTENT OF MUNICIPAL ORDINANCE NO. 09-2012 SPECIFICALLY THE PERIOD WITHIN WHICH FIESTA TIANGGE SHOULD OPERATE

WHEREAS, Municipal Ordinance No. 09-2012 provides, among other regulations that fiesta baratillo stalls or tiangge that operate for the Poblacion or town fiesta may operate only "... not earlier than January 1 but should not extend beyond February 5..";

WHEREAS, the overstaying tiangge stalls have been the subject of numerous complaints from the public market stall owners to drivers and private car owners as there are no space that can be used for parking in the vicinity of the Poblacion market;

WHEREAS, the presence of the fiesta tiangge beyond the authorized duration clearly is a violation of Section 6 of the ordinance;

NOW THEREFORE, on motion of Councilor Ernesto P. Go, unanimously seconded:

BE IT RESOLVED, to remind the Honorable Mayor about the intent of Municipal Ordinance No. 90-2012, specifically the period within which fiesta tiangge should operate.




