



RESOLUTION NO. 070, SERIES OF 2014

REQUIRING ALL CONTRACTORS TO COORDINATE WITH THE MUNICIPAL GOVERNMENT PRIOR TO THE UNDERTAKING OR IMPLEMENTATION OF ANY PROJECT WITHIN THE MUNICIPALITY

WHEREAS, there have been numerous instances or cases wherein projects--mostly infrastructure projects funded by the national government agencies-- are implemented in the municipality without prior coordination with the municipal government;

WHEREAS, more often than not these projects ended up substandard or not actually beneficial to the supposed end-users because of lack of coordination, and usually putting the blame to the LGU officials when these projects leave less-desired results;

WHEREAS, Sec 524 (b) of the Local Government Code of 1991 states that: "No infrastructure or community project within the territorial jurisdiction of any local government unit shall be undertaken without informing the local chief executive and the sanggunian concerned.";

NOW THEREFORE, on joint motion of Councilor Ernesto P. Go and Councilor July A. Vitug, unanimously seconded:

BE IT RESOLVED, to require all contractors to coordinate with the Municipal Government -specifically to the Office of the Mayor and the Sangguniang Bayan- prior to the undertaking of or implementation of any project within the Municipality.


RESOLVED FURTHER, let copies of this resolution be furnished Hon. Mayor Jose Antonio T. Feliciano, Engr. Jose L. Vital, Municipal Engineer, Ms. Marites S. Sigua, MPDC, and all contractors concerned, for their information and or compliance.
