RESOLUTION NO. 084, SERIES OF 2014

REITERATING TO THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO AND MUNICIPAL TREASURER MS. AGNES LACANLALE TO IMPLEMENT TAX ORDINANCE NO. 01-2011 OTHERWISE KNOWN AS "AN ORDINANCE IMPOSING GARBAGE TRANSPORT REGULATORY FEES ON PUBLIC AND PRIVATE HAULERS OF GARBAGE TRAVERSING THE ROADS OF THE MUNICIPALITY OF BAMBAN LEADING TO THE KALANGITAN SANITARY LANDFILL, PURSUANT TO SECTION 155 OF RA 7160 AND FOR OTHER RELATED PURPOSES"

WHEREAS, there is a mounting concern on the need to regulate the transporting and dumping of waste at the Sanitary Landfill and the need to implement strictly Tax Ordinance No. 01-2011 becomes urgent;

WHEREAS, it has been a year since the present administration took over and apparently there is no indication that the said ordinance -specifically the installation of checkpoints to man the incoming garbage trucks from other LGUs and private companies and the issuance of garbage fees tickets- have ever been implemented despite a resolution passed by this Body in 2013 calling for its implementation;

NOW THEREFORE, on motion of Councilor July A. Vitug, unanimously seconded:

BE IT RESOLVED, to reiterate to the Honorable Mayor Jose Antonio T. Feliciano and Municipal Treasurer Ms. Agnes Lacanlale to urgently implement Tax Ordinance No. 01-2011 otherwise known as "An Ordinance Imposing Garbage Transport Regulatory Fees on public and private haulers of garbage traversing the roads of the municipality of Bamban leading to the Kalangitan Sanitary Landfill, pursuant to Section 155 of RA 7160 and for other related purposes"
