



RESOLUTION NO. 093, SERIES OF 2014

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO DONATE ADDITIONAL 250 SQUARE METERS TO BARANGAY ANUPUL FOR EXPANSION OF ITS BARANGAY HALL SITE

WHEREAS, Barangay Anupul, thru its Resolution No. 10 series of 2014 has asked the Municipal Government to execute a deed of donation for an additional area to adjust the present 350 square meters site of the Anupul Barangay Hall to 600 square meters;

WHEREAS, the Committee after a thorough review and consideration of the request deems it proper to grant the same to enable the barangay expand its office building in the future;

NOW THEREFORE, on motion of Councilor Noel S. Rivera unanimously seconded:

RESOLVED, to authorize the Honorable Mayor Jose Antonio T. Feliciano to donate additional 250 square meters to barangay Anupul for expansion of its barangay hall site into a total of 600 square meters, provided that the cost for the conduct of subdivision survey and titling of the property be shouldered by Barangay Anupul.
