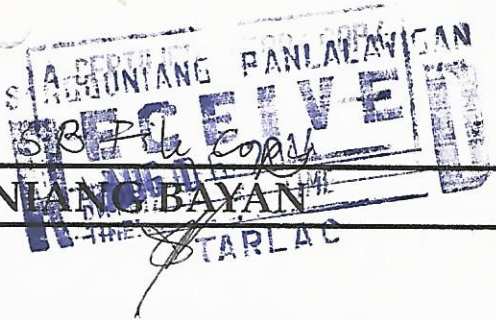

RESOLUTION NO. 095, SERIES OF 2014

REQUESTING THE SANGGUNIANG PANLALAWIGAN OF TARLAC TO CONDUCT AN INVESTIGATION ON THE ALLEGED ACCEPTANCE OF HAZARDOUS WASTE BY THE KALANGITAN SANITARY LANDFILL

WHEREAS, there have been alarming reports received by the Sangguniang Bayan that the Kalangitan Sanitary landfill has been accepting hazardous waste--such as those from hospitals as evidenced by syringes, surgical gloves and dextrose tubes tainted with blood taken out from the landfill by local garbage sorters;

WHEREAS, this Body is aware that the Sangguniang Panlalawigan sometime in 2007 passed SP Resolution No. 019-2007 with a provision stating that it prohibits the dumping of hazardous waste, toxic waste or hospital waste at the Kalangitan Sanitary Landfill;

WHEREAS, this Body believes that the acceptance of hazardous waste and the exposure of local garbage sorters to these hazards is a serious concern that the provincial government should also look into;

NOW THEREFORE, on motion of Councilor July A. Vitug, unanimously seconded:

BE IT RESOLVED, to request the Sangguniang Panlalawigan to conduct an investigation on the alleged acceptance of hazardous waste by Kalangitan Sanitary Landfill which is a violation of environmental regulations and local ordinances/resolutions;


