





WHEREAS, the TUPAD Workers Program is a program of the DOLE that provides assistance to displaced workers and unemployed poor sectors who are coping with the closure or slowing down of operations of companies as a result of economic disruptions, occurrence of natural calamities or armed conflicts that affect their economic base;

WHEREAS, the Memorandum of Agreement governing the implementation of this program in the Municipality has been reviewed by this Body;
