WHEREAS, cattle and carabao branding is being done to establish ownership over the animal and that mandatory branding, locally known as "kintal" of cattles and carabaos and the issuance of Certificate of ownership is provided under Article I of the Revised Revenue Code of the Municipality;

WHEREAS, it has been observed that many cattle/carabao owners do not anymore subject their animal to registration and branding as provided in the local ordinance;

WHEREAS, there have been recent incidents of cattle theft in the municipality and these bring the need to encourage cattle branding and registration for easier identification and establishment of ownership over the missing animals;


NOW THEREFORE, on motion of Councilor Danilo L. Lugtu unanimously seconded:

BE IT RESOLVED, to recommend to the Honorable Mayor to cause the conduct of cattle and carabao branding and registration in all barangays in the municipality pursuant to Article I of the 2004 Revised Revenue Code of the Municipality.
