FELICIANO TO HIRE THE SERVICES OF A PRIVATE LAWYER TO REPRESENT THE MUNICIPAL GOVERNMENT IN A CASE FILED BY JUDY ANN ESGUERRA ET AL, BEFORE THE 2ND MCTC (CAPAS) FOR: EJECTMENT/FORBIBLE ENTRY WITH PRAYER FOR THE ISSUANCE OF A WRIT OF PRELIMINARY INJUNCTION

WHEREAS, a case of Ejectment/Forcible Entry with Prayer for the Issuance of a Writ of Preliminary Mandatory Injunction was filed by Judy Ann Esguerra, et al against Mayor Jose Antonio T. Feliciano before the 2nd MCTC (Capas) docketed as Civil Case No. 2774-14;

WHEREAS, the case stemmed from the construction of a Triple A Poultry Dressing plant - a project of the Municipal Government funded by the Department of Agriculture - at a ten (10) hectare property of the Municipal Government in DapDap Resettlement Area over which Plaintiffs claim right of possession;


