APPROVING AND CONFIRMING TAX ORDINANCES NO. 01, 02, AND 03, ALL
CURRENT SERIES, OF BARANGAY LAPAZ, AS WITHIN THE SCOPE OF TAXING
POWERS OF THAT BARANGAY AND THEREFORE VALID

WHEREAS, the following Tax Ordinances of Barangay Lapaz had been submitted for review
of the Sangguniang Bayan thru the Committee on Legal Matters and Finance & Appropriation:

1. Tax Ordinance No. 01, s, 2014 "An Ordinance Imposing Fee for the Issuance of Barangay Business Permit to the Lessor who intends to Operate Business for the Rental of Apartment"
2. Tax Ordinance No. 02, s. 2014 "An Ordinance Imposing Fee for the Issuance of Barangay Certification to the Scrap Buying (Bakal Bote)"
3. Tax Ordinance No. 03, s. 2014 "An Ordinance Imposing Fee for the Issuance of Barangay Business Permit for Peddlers Engaged in an Installment Basis"

WHEREAS, in the review, said Tax Ordinances No. 01, 02 and 03 all current series have
been found in consonance with Article 240 of IRR of RA 7160 (Local Government Code) under the
Scope of Taxing Powers of Barangays;


NOW THEREFORE, on motion of Councilor Ernesto P. Go, unanimously seconded:
