RESOLUTION NO. 128, SERIES OF 2014

RECOMMENDING TO THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO MAKE A FOLLOW-UP COLLECTION EFFORT IN CONNECTION WITH THE BUY BACK OFFER OF ATTY. ARNALDO DIZON FOR A 1,300 SQ.M. PROPERTY SOLD TO THE MUNICIPAL GOVERNMENT OF BAMBAN IN 2002 AT P400,000.00

WHEREAS, the Municipal Government in 2002 acquired a total of 1,300 sq. meter property from Atty. Arnaldo Dizon by way of donation (500 sq.m) and purchase (800sq.m) supposedly to serve as site of a municipal slaughterhouse but was subsequently offered for buy back in 2004 by Atty. Dizon at the same price it was sold to the municipal government in 2002 at P400,000.00;

WHEREAS, official records show that the Municipal Government accepted in 2004 the buy back offer of Atty. Dizon and the cancellation of the deed of sale that was executed, but a certification from the Municipal Treasurer dated December 5, 2006 also show that Atty. Dizon was able to pay the Municipal Government only Twenty Thousand Pesos (P20,000.00) thus incurring an outstanding balance of P380,000.00;

WHEREAS, the Sangguniang Bayan in 2006 repeatedly urged the then Mayor Leonardo Anunciacion to initiate collection efforts in connection to the said buy back offer of Atty. Dizon but to no avail;

RESOLVED, this Body believes that the Municipal Government has long been in a losing end with regards to this transaction and it is about time that collection efforts be initiated by the incumbent Mayor;

NOW THEREFORE, on motion of Councilor Ernesto P. Go, unanimously seconded:

BE IT RESOLVED, to recommend to the Honorable Mayor Jose Antonio T. Feliciano to make a follow-up collection effort with regards to the buy back offer of Atty. Arnaldo Dizon made in 2004 for a total of more or less 1,300 sq.m. property he sold to the Municipal Government of Bamban in 2002 at a price of P400,000.00 .
