


LUMBOY, RURAL HEALTH PHYSICIAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DIVINE MERCY HOSPITAL FOR THE IMPLEMENTATION OF TUBERCULOSIS CONTROL PROGRAM IN THE MUNICIPALITY OF BAMBAN AND PROVISION FOR VARIOUS LABORATORY PROCEDURES
