



RECOMMENDING TO THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO RELOCATE  
THE PNP SUB STATION FROM ITS PRESENT LOCATION AT THE GROUND FLOOR OF THE  
LIBRARY BUILDING TO THE BAMBAN PUBLIC MARKET

WHEREAS, one of the thrusts of the present administration is to promote literacy among the population by advocating reading and love for books and other informative materials which shall be made possible thru the improvement of the Municipal Library;

WHEREAS, in pursuit of said objective, there is a need to put up a children's library and activity center at the ground floor of the Municipal Library building which is presently being occupied by the local PNP as a sub station;

WHEREAS, this Body is cognizant of the importance of a PNP substation present in the busy Poblacion area but needs to relocate it from its present location at the ground floor of the Municipal Library Building in order to give way to the establishment of a children's library;

NOW THEREFORE, on joint motion of Councilor July A. Vitug and Councilor Reynaldo L. Pangilinan, Sr.:

BE IT RESOLVED, to recommend to the Honorable Mayor Jose Antonio T. Feliciano to relocate the PNP sub-station from its present location at the ground floor of the Municipal Library Building to the available space(s) at the Bamban Public market, and that the Municipal Government shall:

1. Allocate funds for the immediate improvement of the new/temporary police outpost and sleeping quarters of PNP personnel; and
2. Construct a permanent sub station within the premises of the Bamban Public Market


