SUPPORTING THE INTENT OF BARANGAY ANUPUL TO PROHIBIT ALL GARBAGE LOADED AND HOG-CARRYING VEHICLES FROM PASSING THROUGH THE PAG-ASA-KAWILI-WILI ROAD DUE TO THE BADLY DAMAGED BARANGAY ROAD

WHEREAS, among the concerns raised in the letter of Honorable Mayor Jose Antonio T. Feliciano to the SB dated November 19, 2014 is the need to prohibit garbage loaded and hog-carrying trucks from passing through the Pag-Asa-Kawili-wili road as these had caused extensive damage to the said barangay road and have been the subject of complaints from the residents;

WHEREAS, this Body understands the concerns of the people of Barangay Anupul, as conveyed thru their Punong Barangay;

WHEREAS, Section 21 of RA 7160 mandates that "LGUs may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park or square falling within its jurisdiction: Provided, however, that in case of permanent closure, such ordinance must be approved by at least two thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided"

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, that this Body hereby supports the intent of Barangay Anupul to prohibit all garbage loaded and hog-carrying vehicles from passing through the Pag-Asa-Kawili-wili Road due to the badly damaged barangay road, by exercising its power under Section 21 of the Local Government Code of 1991 provided that a public hearing must be conducted prior to the enactment of an ordinance.
