

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO SIGN THE
SECONDMENT AGREEMENT WITH THE HUMAN RIGHTS VICTIMS CLAIMS BOARD
(HRVCB) FOR THE SERVICES OF MS. ANNETTE C. CASTANEDA TO THE BOARD FROM
NOVEMBER 3, 2014 TO NOVEMBER 4, 2015

WHEREAS, the HRVCB has sought the services of Ms. Anette C. Castaneda, LGU employee, to provide para legal services to human rights victims in Central Luzon pursuant to the intent of RA 10368 also known as "Human Rights Victims Reparation and Recognition Act of 2013";

WHEREAS, Ms. Castaneda may render said services to the Board thru a secondment that may be agreed upon by the HRVCB and the LGU in accordance with Section 6, Rule III of CSC MC No. 40, s. 1998, as amended by CSC MC No. 14, s. 1999;

WHEREAS, under the agreement, Ms Castaneda shall render a one year service to the Board and will be entitled to a monthly compensation, during which she will be on an official leave from the LGU without pay;

NOW THEREFORE, on motion of Councilor Alvin Dale Sibal, unanimously seconded:

BE IT RESOLVED, to authorize the Honorable Mayor Jose Antonio T. Feliciano to sign a Secondment Agreement with the Human Rights Victims Claims Board (HRVCB) for the secondment of Ms. Anette Castaneda to the HRVCB from November 3, 2014 to November 4, 2015.
