*EXPLANATORY NOTE*

WHEREAS, there is a need to amend certain provisions of Municipal Ordinance No. 10-2012 to rectify some inconsistencies in body color of tricycles , location of terminals and franchise fees being imposed;

WHEREAS, Section 6 (Franchise and other fees) of said ordinance provides the amounts imposed in the grant of tricycle franchise, permits, filing fees, among others but failed to mention that these are subject to adjustment based on the Revised Revenue Code of the Municipality;

WHEREAS, Section 7 (Recognized tricycle associations, terminals and their respective routes) of the same ordinance has to be revised so as to change the color codes assigned to certain terminals to avoid confusion;

NOW THEREFORE, on motion of Councilor Reynaldo L. Pangilinan, Sr., unanimously seconded:

BE IT RESOLVED, to enact :

MUNICIPAL ORDINANCE NO. \_\_ -

AN ORDINANCE AMENDING SECTIONS 6 AND 7 OF MUNICIPAL ORDINANCE NO. 10-2012 OTHERWISE KNOWN AS "AN ORDINANCE REGULATING THE OPERATION OF MOTORIZED TRICYCLES, THE GRANTING OF FRANCHISE FOR THE OPERATION THEREOF AND REGULATING THE ESTABLISHMENT OF TERMINALS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BAMBAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF"

Be it enacted by the Sangguniang Bayan in session assembled, that:

Section 1. Section 6 of the ordinance is hereby amended, to add:

" 6.1 The fees herein imposed shall be subject to adjustment based on the Revised Revenue Code of the Municipality."

Section 2. Section 7 of the ordinance is hereby amended to read:

1. Association: San Nicolas Poblacion Bamban TODA  
Color code: White  
Terminal: Punsalan St. and Lamcel St. Poblacion Bamban
2. Association: Market Poblacion MPMTODA  
Color Code: Blue  
Terminal: East of Manipon St., San Nicolas

ANUPUL AREA:

5. Association: Anupul Junction-Bamban DapDap (AJBDBTODA)  
Color code: Red  
Terminal: Anupul Junction Highway  
Sub-terminals: Infront of Jun's Mart, SACOT, Banaba -DapDap

Section 3. All other provisions of Municipal Ordinance No. 10-2012 not herein modified or amended shall remain in force and effect.

Section 4. This ordinance shall take effect immediately upon approval.
