RESOLUTION NO. 016, SERIES OF 2016

RECOMMENDING TO THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO ISSUE A CEASE AND DESIST ORDER TO THE BUSINESS OPERATOR OCCUPYING THE BUILDING IN SITIO MANO (RIGHT BESIDE THE DAPDAP PUBLIC CEMETERY) FOR OPERATING WITHOUT THE NECESSARY PERMIT AND TO ORDER THE ALLEGED OWNER OF SAID (RESIDENTIAL) BUILDINGS TO VACATE SAID PROPERTY BEING ILLEGALLY CONSTRUCTED IN A GOVERNMENT-OWNED PROPERTY

WHEREAS, it has been a public knowledge that a private residential building or buildings were constructed by former Mayor Leonardo C. Anunciacion some years ago at a property that sits right beside the DapDap Public Cemetery in Sitio Mano, DapDap Resettlement Area and that the latest information gathered by this Body is that a business activity –without local permits- has been going on for some time in the said building(s) ;

WHEREAS, it has been the concern of the present administration that illegally constructed structures within the DapDap Resettlement Area be ordered demolished or vacated especially on areas that may otherwise be utilized by the Municipal Government for its public facilities;

NOW THEREFORE, on motion of Councilor Ernesto M. Salting, unanimously seconded:

BE IT RESOLVED, that this Body hereby recommend to the Honorable Mayor Jose Antonio T. Feliciano to issue a cease and desist order to the business operator occupying the residential building(s) in Sitio Mano that are located right beside the DapDap Public Cemetery for operating without the necessary permit and to order the alleged owner of said residential building(s) to vacate said property for being illegally constructed in a government-owned property.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano, Engr. Jose L. Vital, Municipal Engineer, Ms. Agnes M. Lacanlale, Municipal Treasurer, and others concerned, for their information and appropriate action.
