RESOLUTION NO. 018, SERIES OF 2016

REQUESTING THE OFFICE OF THE MAYOR TO IMMEDIATELY CONDUCT AN OCULAR INSPECTION-THRU THE MUNICIPAL AGRICULTURIST AND MUNICIPAL ENGINEER- OF THE QUARRY AREA IN BARANGAY MALONZO AND ITS ADJOINING BARANGAYS AND TO RENDER A REPORT TO THE SANGGUNIANG BAYAN PERTAINING TO THE PRESENT PHYSICAL CONDITION OF THE AGRICULTURAL /RESIDENTIAL LANDS REPORTEDLY BEING EXCAVATED IN TOTAL DISREGARD OF MUNICIPAL ORDINANCE NO. 04-2009

WHEREAS, there have been reports that unabated excavation activities are being conducted in Barangay Malonzo that have resulted to deep and wide excavations, despite regulations imposed under Municipal Ordinance No. 04-2009 otherwise known as "*An Ordinance Prescribing the Guidelines in the Conduct of Quarry or Excavation Activities in All Agricultural Areas of Identified Barangays in the Municipality of Bamban*";

WHEREAS, this Body is concerned that the provisions of said ordinance are not being implemented by local officials who are supposedly in control and are not observed by quarry operators or excavators and that if this continues, the said area will no longer serve an ideal site for any future industrial development activity such as the prospective Special Economic Zone being considered in the updating of the Comprehensive Land Use Plan (CLUP);

WHEREAS, this Body deems it necessary that an immediate ocular inspection be conducted so as to assess the situation in the said area and to guide the Sangguniang Bayan on what subsequent action to be taken;

NOW THEREFORE, on motion of Councilor Ernesto P. Go, duly seconded:

BE IT RESOLVED, to request the Office of the Mayor –to immediately conduct an ocular inspection-thru the Municipal Agriculturist and Municipal Engineer – of the quarry area in Barangay Malonzo and its adjoining barangays and to render a report to the Sangguniang Bayan pertaining to the present physical condition of the agricultural/residential lands reportedly being excavated in total disregard of Municipal Ordinance NO. 04-2009.

RESOLVED FURTHER , let copies of this resolution together with a copy of Municipal Ordinance No. 04-2009 be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and be furnished Mr. Julio Silvestre, Municipal Agriculturist, Engr. Jose L. Vital, Municipal Engineer, PB Fernando David of Brgy. Malonzo, and others concerned, for their information and appropriate action.
