RESOLUTION NO. 019, SERIES OF 2016

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FIRE PROTECTION FOR THE RELEASE TO THE LGU OF THE 20% SHARE ALLOCATION OF FIRE CODE REVENUES

WHEREAS, submitted for review of this Body and for its authorization to sign is the Memorandum of Agreement between the Bureau of Fire Protection Central Office and the Municipal Government that provides for the allocation of the twenty (20%) per cent share in Fire Code Revenues from CY 2010 to 2013 which shall be released to the Municipality and which will be used exclusively for operation and maintenance of the local BFP fire station and acquisition of equipment;

WHEREAS, the MOA is favorable and advantageous to the Municipality as it will benefit greatly from the improved services of the local BFP station once the projects from this fund are implemented accordingly;

NOW THEREFORE, on motion of Councilor Ernesto P. Go duly seconded by Councilor Jose M. Salting, Jr. :

BE IT RESOLVED, to authorize , as it is hereby authorized, the Honorable Mayor Jose Antonio T. Feliciano to enter into a Memorandum of Agreement with the Bureau of Fire Protection for the release to the LGU of the 20% share allocation of fire code revenues

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and the BFP Central Office for their necessary action , and be furnished SFO1 Allan Cuya, Bamban BFP Station , and others concerned, for their information.
