RESOLUTION NO. 020, SERIES OF 2016

REQUESTING THE NATIONAL HOUSING AUTHORITY TO APPROPRIATE FUNDS FOR THE COMPENSATION CLAIM OF THE HEIRS OF ABELARDO CUYUGAN FOR THEIR MORE OR LESS, 38 HECTARES PROPERTY LOCATED WITHIN THE DAPDAP RESETTLEMENT AREA IN THE MUNICIPALITY OF BAMBAN, PROVINCE OF TARLAC

WHEREAS, the National Housing Authority on February 13, 2014 (NHA) turned over to the Municipal Government of Bamban by way of Deed of Transfer and Acceptance (DOTA) the entire DapDap Resettlement Area covering 166.3035 hectares ;

WHEREAS, one condition stipulated in the DOTA, (condition #9) states that “ *That any pending claim, action or proceeding by or against the NHA such as the claim of the heirs of Mr. Abelardo Cuyugan with TCT No. 15162 shall still be answerable by the NHA upon proper motion to be made in the court or body where such claim, action or proceeding is pending and upon order of said court or body for the substitution of parties in accordance with the Rules of Court on transfer of interests*”

WHEREAS, the Municipal Government is aware that the heirs of Abelardo Cuyugan have a standing compensation claim for their more or less 38 hectares property situated within the DapDap Resettlement Area ;

WHEREAS, the Municipal Government is concerned that with the standing compensation claim for the property , Municipal Government cannot freely and completely implement development projects in the particular portions of the resettlement area;

NOW THEREFORE, on motion of Councilor Noel S. Rivera , unanimously seconded:

BE IT RESOLVED, to request the National Housing Authority to appropriate funds for the compensation claim of the heirs of Abelardo Cuyugan for their more or less 38 hectares property located within the DapDap Resettlement Area in the Municipality of Bamban.

RESOLVED FURTHER, let copies of this resolution be forwarded to the NHA at NHA Building, Elliptical Road, Diliman, Quezon City, for their information and favorable action and be furnished Hon. Mayor Jose Antonio T. Feliciano for his information and or endorsement.
