RESOLUTION NO. 031, SERIES OF 2016

APPROVING THE TRANSFER OF LOCATION OF THE SOON TO BE CONSTRUCTED BUB-FUNDED MULTI-PURPOSE PAVEMENT FROM ITS ORIGINAL PROPOSED SITE IN BARANGAY CULUBASA TO SITIO QUEMATEN DAMULAG, ALSO IN THE SAME BARANGAY

WHEREAS, the Honorable Mayor wrote the Sangguniang Bayan to ask for its approval to transfer the location of the soon to be constructed multi-purpose pavement which is funded by the DILG's Bottoms – Up Budgeting (BUB) Program;

WHEREAS, the original location in Barangay Culubasa has been inspected and found to be not feasible due to the fact that it is a private property and the LGU may have to procure it should the owner is unwilling to donate the property;

WHEREAS, the alternative site is in Sitio Quematen Damulag, which is also found in the same barangay and is a government property, (being a former site of Culubasa Elementary School), aside from being wide enough to accommodate additional facilities like multi-purpose building or mechanical dryer;

NOW THEREFORE, on motion of Councilor Ernesto M. Salting, unanimously seconded:

BE IT RESOLVED, to approve, as it is hereby approved, the transfer of location of the soon to be constructed BUB-funded multi-purpose pavement from its original proposed site in Barangay Culubasa to Sitio Quematen Damulag, also in the same barangay.

RESOLVED FURHER, to recommend that a relocation survey of said government property be conducted to facilitate land development.

RESOLVED FURTHERMORE, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and be furnished Engr. Jose L. Vital, Municipal Engineer and all others concerned, for their information and appropriate action.
