AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE EARLY CHILDHOOD CARE AND DEVELOPMENT COUNCIL (ECCD COUNCIL) FOR THE CONSTRUCTION OF A CHILD DEVELOPMENT CENTER IN BARANGAY ANUPUL, THIS MUNICIPALITY
