RESOLUTION NO. 038, SERIES OF 2016

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO ALLOW THE DEPARTMENT OF EDUCATION (DepEd) /DAPDAP HIGHSCHOOL TO UTILIZE TWO (2) SPECIFIC LOCATIONS IN DAPDAP RESETTLEMENT AREA FOR THE CONSTRUCTION AND ESTABLISHMENT OF SENIOR HIGH SCHOOL BUILDING AND TECH-VOC WORKSHOP

WHEREAS, the Honorable Mayor Jose Antonio T. Feliciano in his letter dated August 15, 2016 has requested the Sangguniang Bayan to authorize the allocation of sites at the DapDap Resettlement Area for the construction and establishment of senior high school building and Tech-Voc workshop being provided by the DepEd, at the following identified sites :

1. *the block(s) where the PNP and Fire Station buildings and other privately-owned structures are presently located; and*
2. *the vacant space near the DapDap gymnasium (previously proposed site for boxing gym)*

WHEREAS, the Sangguniang Bayan shares the commitment of the Honorable Mayor to strongly support the implementation of senior high school program of the DepEd by way of allowing its establishment at the DapDap Resettlement so that local students will no longer seek to enroll in schools outside DapDap and thus save them and their families from inconvenience and costly transportation expenses;

NOW THEREFORE, on joint motion of Councilors Ernesto P. Go, Noel S. Rivera and Danilo Lugtu, unanimously seconded:

BE IT RESOLVED, that as a manifestation of support to the implementation of senior high school program of the Department of Education (DepEd) in this Municipality, the Sangguniang Bayan hereby authorizes the Honorable Mayor Jose Antonio T. Feliciano to allow the DepEd /DapDap High school to utilize the two (2) above specified locations in DapDap Resettlement Area for the construction and establishment of senior high school building and tech-voc workshop, provided however, that the government offices that will be affected be properly relocated and the illegal occupants/structures existing therein be properly dealt with.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano, Engr. Rosanna S. Calara, MPDC, Engr. Jose L. Vital, Municipal Engineer, Ms. Amparo Munoz, DapDap High school principal, the DepEd Schools Division of Tarlac Province, and all others concerned, for their information and appropriate action.
