RESOLUTION NO.039 , SERIES OF 2016

IMPOSING STRINGENT PENALTY TO ABSENTEEISM IN SB COMMITTEE MEETINGS/HEARINGS,
AMENDING FOR THE PURPOSE RULE IV, SECTION 18 OF THE SB INTERNAL RULES AND
PARLIAMENTARY PROCEDURES

WHEREAS, absenteeism in committee meetings, hearings or public hearings has a negative effect in legislative process as it results to lack of quorum or failure to promptly arrive at a sound decision on matters referred to a committee for study and recommendation ;

WHEREAS, to stop members from committing absences in committee meetings, it is necessary to impose a more stringent penalty to every erring member;

NOW THEREFORE, on motion of Councilor Ernesto Salting and Councilor Ernesto P. Go, unanimously seconded:

BE IT RESOLVED, that this Body hereby agree on the following:

1. *Impose a penalty of five hundred (Php500.00) pesos to every member for every absence in a scheduled committee meeting/hearing or public hearing as mandated in Rule IV Section 18 of the Internal Rules of the Sanggunian.*
2. *The penalty shall be charged to and collected outright from the erring member upon his attendance during the next regular session in which the amount shall be spent for snacks of the Sanggunian.*
3. *Exemption shall be granted to members who have to attend to dire emergency such as medical check- up, confinement, attending a seminar, official meeting, death of a family member wherein it would be impossible for him to attend the scheduled meeting. Such absence shall be supported by documentary proof (except death of a close family member), which will be submitted to the committee chair thru the SB Secretary.*

RESOLVED FURTHER, let copies of this resolution be filed together with the approved Internal Rules and Parliamentary Procedures as it amends Rule IV Section 18 of the said house rules.
