RESOLUTION NO. 047, SERIES OF 2016

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO FILE EJECTMENT
CASE AGAINST ALL ILLEGAL OCCUPANTS IN
DAPDAP RESETTLEMENT AREA

WHEREAS, the existence of illegally constructed structures or occupants at certain areas of the DapDap Resettlement and the need to get rid of them has once again challenged the Municipal Government which is faced with the problem of where to place very important institutional facilities such as senior high school buildings being offered by the DepEd, among others;

WHEREAS, recently the Sangguniang Bayan thru its Resolution No. 038 series of 2016, authorized the Honorable Mayor to allow the DepEd to utilize certain locations at the DapDap Resettlement as site for the proposed senior high school buildings, but unfortunately, those specific locations are being occupied by illegally –built structures;

WHEREAS, in his letter to the Sangguniang Bayan dated September 13, 2016 the Honorable Mayor requested that he be authorized to file an ejectment case against the illegal occupants/structures to pave the way for the construction of institutional facilities such as the senior high school buildings being offered to be built by the DepEd;

WHEREAS, this Body is convinced that in order for the Municipal Government to achieve its objective of re-organizing the physical structures and development of the DapDap Resettlement Area and at the same time provide the needed facilities for the enjoyment and benefit of a greater number of its constituents , a legal procedure is necessary and is in order;

NOW THEREFORE, on motion of Councilor Ernesto P. Go, unanimously seconded:

BE IT RESOLVED, to authorize the Honorable Mayor Jose Antonio T. Feliciano to file ejectment case against all illegal occupants in DapDap Resettlement Area.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and be furnished all others concerned, for their information and necessary action.
