RESOLUTION NO. 048, SERIES OF 2016

ADOPTING THE REPORT AND RECOMMENDATION OF THE COMMITTEE ON MARKET &
SLAUGHTERHOUSE REGARDING THE REQUEST FOR CONSIDERATION OF
MR. RODOLFO ESCOTO

WHEREAS, the Sangguniang Bayan received and discussed –thru the Committee on Market & Slaughterhouse – the request of former Councilor Rodolfo Escoto who has been asking for the SB's consideration and allow him to maintain the makeshift space he's been occupying at the rear end of the Bamban Public Market since he gave up and sold the stall he used to occupy at the market as meat vendor;

WHEREAS, under the Public Market Code (Municipal Ordinance No. 04-2006), it is prohibited to sell to another the stall awarded to any vendor especially without the prior knowledge of the market administration and likewise it is prohibited to occupy space not intended for displaying commodities – such as passageways and parking areas - especially food as delicate as raw meat when there is a designated section for selling such;

WHEREAS, the Committee as it maintained in its committee report, adheres to the provisions of the Market Code;

NOW THEREFORE, on motion of Councilor Alvin Dale Sibal, unanimously seconded:

BE IT RESOLVED, that this Body hereby adopts the attached Report and Recommendation of the Committee on Market & Slaughterhouse dated September 20, 2016 regarding the request for consideration of Mr. Rodolfo Escoto
