RESOLUTION NO. 063, SERIES OF 2016

LIFTING THE WORK STOPPAGE OF THE TRIPLE A POULTRY DRESSING PLANT CONSTRUCTION THAT WAS AUTHORIZED ON MARCH 4, 2016 BY THE SANGGUNIANG BAYAN

WHEREAS, on March 4, 2016 and acting on the request of the Honorable Mayor Jose Antonio T. Feliciano, the Sangguniang Bayan authorized the work stoppage of the construction of the Triple A Poultry Dressing Plant due to the problem in the process of titling of Block 111, which is the site of the dressing plant;

WHEREAS, on November 2, 2016 the Honorable Mayor wrote again to request the Sangguniang Bayan to lift the work stoppage in view of the development that recently took place, that is, that the application for titling of the Block 111 was favorably endorsed by the DENR as gleaned from the communications of the DENR Regional Director to the Honorable Mayor dated September 20, 2016;

WHEREAS, the Sangguniang Bayan shares the view of the Honorable Mayor that with the lifting of the work stoppage, the contractor of the poultry dressing plant may now resume the construction and eventually complete the project.

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, that the Sangguniang Bayan hereby lifts the work stoppage that it authorized for the construction of the Triple A Poultry Dressing Plant project

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano, the Northern Builders thru Mr. Victor M. Angeles, Engr. Jose L. Vital, and all others concerned, for their information and appropriate action.
