RESOLUTION NO. 079, SERIES OF 2016

REQUESTING THE HONORABLE MAYOR TO CAUSE THE IMPROVEMENT OR REPAIR OF
DAPDAP COVERED COURT, ANUPUL COVERED COURT AND IMMEDIATE
REPLACEMENT OF UNFUNCTIONING STREETLIGHTS IN THE MUNICIPALITY BY
UTILIZING SPECIAL PURPOSE APPROPRIATION FOR REHABILITATION/MAINTENANCE
OF COVERED COURTS AND 20% EDF (STREETLIGHTING)

WHEREAS, it has been the observation of many that multi-purpose buildings or covered courts – specifically the DapDap gym and Anupul covered court (located at the back of municipal hall), which are very useful venues for mass gatherings or programs have been wanting of repair as evident by unfunctioning lights, dilapidated fences, among others;

WHEREAS, many streetlights have not been working for a long time and are in need of replacement / repair ;

WHEREAS, this Body understands that there are appropriations earmarked for these purpose in the 2017 budget;

NOW THEREFORE, on motion of Councilor Johnny M. Sales, unanimously seconded:

BE IT RESOLVED, to request the Honorable Mayor to cause the improvement or repair of DapDap covered court, Anupul covered court and immediate replacement of unfunctioning streetlights in the municipal roads by utilizing appropriations under the Mayor's Office (Special Purpose Appropriation) and 20% EDF , and that these objects of expenditures be given priority in the first quarter of 2017.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and be furnished Ms. Rowena T. Manalese, Acting Budget Officer, and others concerned, for their information and appropriate action.
