EXPRESSING GRATITUDE TO THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO, ABC  
PRESIDENT JOSE SALTING, JR, PB FORTUNATO V. MEJIA AND OTHERS WHO HELPED IN  
PUTTING UP A TEMPORARY DIKE TO SUPPORT THE OPERATION OF THE BAMBAN  
COMMUNAL IRRIGATION SYSTEM

WHEREAS, lack of irrigation water to farm lots due to the still unmodified structural deficiencies of the Bamban Communal Irrigation system has taken its toll to hectares of rice crops and has forced the affected farmers to seek remedies to promptly address their problem;

WHEREAS, the heavy equipment lent to the farmers by no other than Mayor Jose Antonio T. Feliciano, and the fuel supplied by ABC President Jose Salting Jr., PB Fortunato Mejia (Brgy. San Nicolas) and some farmers enabled the construction of a temporary dike that would support the distribution of irrigation water to dried farmlands;

NOW THEREFORE, on motion of Councilor Danilo Lugtu, unanimously seconded:

BE IT RESOLVED, that this Body, on behalf of the local farmers concerned hereby expresses gratitude to the Honorable Mayor Jose Antonio T. Feliciano, ABC President Jose Salting, Jr., PB Fortunato Mejia and some farmers (who contributed financially and in some other ways) thereby making possible the construction of a temporary dike to support the operation of the Bamban Communal Irrigation system
