RESOLUTION NO. 085, SERIES OF 2016

INTERPOSING NO OBJECTION TO THE RE-IMPOSITION OF MINIMUM SERVICE CHARGE
BY CLPI- BAMBAN WATERWORKS TO ITS CONSUMERS IN THE MUNICIPALITY
STARTING JANUARY 2017 BILLING

WHEREAS, the imposition of minimum service charge to every consumer of Bamban Waterworks was suspended by the Bamban Waterworks management in December 2015 due to the perennial complaints of poor water service from its consumers;

WHEREAS, almost a year hence, and with the management 's assurance that it has generally improved its services to its local consumers, the Bamban Waterworks on October 26, 2016 proposed to bring back the minimum rate/service charge to its consumers (starting October 4, 2016 -November 3, 2016 reading date, onwards);

WHEREAS, in the committee meetings held for the purpose, the Bamban Waterworks managers (Bamban and DapDap Branches) were able to convince the Sangguniang Bayan that services offered to its customers have generally improved because of various improvements/projects that were undertaken in their service areas in the past months , although the management admitted that there is still a lot of improvement to be done when it comes to its Mainang resettlement service area;

NOW THEREFORE, on joint motion of Councilor Ernesto Salting and Councilor Ernesto Go, unanimously seconded:

BE IT RESOLVED, that the Sangguniang Bayan hereby interposes no objection to re-imposition of minimum service charge by CLPI-Bamban Waterworks to its local consumers at Bamban Poblacion and DapDap service areas , with exception of Mainang Resettlement service area, effective January 2017 billing.

RESOLVED FURTHER, let copies of this resolution be furnished the CLPI-Bamban Waterworks thru Ms. Joy C. Cenizal, Branch Manager –Bamban, Ms. Marissa B. Mangalino, Branch Manager-DapDap, Hon.
