RESOLUTION NO. 351, SERIES OF 2016

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO SUSPEND THE IMPLEMENTATION OF MUNICIPAL ORDINANCE NO. 23-2015 UNTIL DECEMBER 31, 2016 WHILE THE ACCESS ROAD TO THE KALANGITAN SANITARY LANDFILL IS BEING REHABILITATED OR DEVELOPED

WHEREAS, Municipal Ordinance No. 23-2015 entitled, "An Ordinance Prohibiting All Garbage Loaded Vehicles Bound for Kalangitan Sanitary landfill to Enter the Anupul-Pag-Asa-DapDap Road or Sitio Mainang Road in the Municipality of Bamban" - lapsed into law or took effect into law on October 1, 2015 ;

WHEREAS, since its enactment there had been requests from certain sectors to suspend its implementation including Mayor Feliciano himself, Mr. Rufo Colayco of the Metro Clark Waste Management Corp.(MCWMC) , and the League of Municipalities from Tarlac , citing that this will result to a garbage crisis as the Capas access road to the landfill is not suitable/passable to most MCWMC trucks and other LGU trucks of different municipalities of the Province of Tarlac;

WHEREAS, in January 2016 both Mayor Feliciano and Mr. Rufo Colayco of MCWMC again wrote to ask also for a temporary suspension of the ordinance ;

WHEREAS, the Sangguniang Bayan initially refused to grant said requests for suspension of implementation –although in truth and in fact the provisions of the ordinance had yet to be implemented actually - , but is now

convinced that the moratorium be granted so as to give a chance to Mayor to negotiate for the acquisition of an access road in Bamban and for the development of the same;

NOW THEREFORE, on motion of Councilor Jose Salting, Jr. duly seconded by Councilors Robin Mangiliman, Danilo L. Lugtu, Noel S. Rivera, and Reynaldo L. Pangilinan, Sr.:

BE IT RESOLVED, to authorize the Honorable Mayor Jose Antonio T. Feliciano to suspend the implementation of Municipal Ordinance No. 23-2015 otherwise known as " An Ordinance Prohibiting All Garbage Loaded Vehicles Bound for Kalangitan Sanitary landfill to Enter the Anupul-Pag-Asa-DapDap Road or Sitio Mainang Road in the Municipality of Bamban" until December 31, 2016, provided however, that there shall be no further extension afterwards.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and be furnished the Metro Clark Waste Management Corp. (MCWMC) and others concerned, for their information and appropriate action.
