RESOLUTION NO. 353, SERIES OF 2016

AUTHORIZING THE WORK STOPPAGE OF TRIPLE A POULTRY DRESSING PLANT
CONSTRUCTION UNTIL SUCH TIME THE LAND TITLE OF THE DRESSING PLANT SITE
(BLOCK 111) SHALL HAVE BEEN ISSUED IN FAVOR OF THE
MUNICIPALITY OF BAMBAN

WHEREAS, in his letter to the Sangguniang Bayan dated February 29, 2016 , the Honorable Mayor Jose Antonio T. Feliciano asked the Sangguniang Bayan to “issue the necessary resolution for work stoppage” of the Triple A Poultry Dressing Plant citing “ problem in the process of titling of Block 111 where the construction of AAA Poultry Dressing Plant is being held”;

WHEREAS, Mayor Feliciano further explained in his letter that “the continuous construction might result into wastage of government funds without first settling the issue, thus we have to finalize and put a conclusion on the titling of the said location before pursuing / finishing the construction” and “put an end to the harassment issue that may pause imminent danger to Northern Builders employees on site”;

WHEREAS, this Body, after reviewing the communications sent by the DENR pertaining to the processing of land title application for Block 111 is convinced that the Mayor’s concern on the matter is valid, necessary and deserves to be supported;

NOW THEREFORE, on motion of Councilor Noel S. Rivera unanimously seconded:

BE IT RESOLVED, to authorize the immediate work stoppage of the Triple A Dressing Plant construction by Northern Builders until such time the land title of the dressing plant site which is otherwise known as Block 111 shall have been issued in favor of the Municipality of Bamban.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano, Mr. Victor Angeles of Northern Builders, the NMIS thru Dr. Minda Manantan, Ms. Fe M. San Pedro, Municipal Accountant, Engr. Jose L. Vital, Municipal Engineer, Engr. Rosanna S. Calara, and others concerned, for their information and appropriate action.
