A RESOLUTION CREATING THE LOCAL VERIFICATION COMMITTEE (LVC) PURSUANT TO DILG MEMORANDUM CIRCULAR NO.2015-69 DATED JULY 01, 2015 TO ATTAIN THE PROJECT'S OBJECTIVE AND ENSURE THE TRANSPARENCY AND ACCURACY OF THE DATA COLLATED OF THE LISTAHANAN OR THE NATIONAL HOUSEHOLD TARGETING SYSTEM FOR POVERTY REDUCTION (NHTSPR) PROJECT OF THE DSWD
