RESOLUTION NO. 364, SERIES OF 2016

ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT PLAN (MDRRMP)
OF THE MUNICIPALITY OF BAMBAN (2015-2019)

WHEREAS, Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 and its Implementing Rules and Regulation mandates, among others, the preparation and adoption of a long term disaster plan by every local government unit;

WHEREAS, the Municipal Disaster Risk Reduction Management Plan of the Municipality of Bamban covers the period from 2015 to 2019 and focuses on Disaster Mitigation, Disaster Preparedness, Disaster Prevention, Post-Disaster Recovery and Rehabilitation;

WHEREAS, this Body is convinced that the plan is necessary in order to effectively guide the local implementers and authorities assigned in disaster response and mitigation and thus attain a minimized if not a zero casualty and minimal damage to properties during disaster and calamities;

NOW THEREFORE, on motion of Councilor Reynaldo L. Pangilinan, Sr. unanimously seconded:

BE IT RESOLVED, that this Body hereby adopts the Municipal Disaster Risk Reduction Management Plan (MDRRMP) of the Municipality of Bamban covering the period 2015 to 2019, copy of which is attached and forms an integral part of this resolution.
