RESOLUTION NO. 366, SERIES OF 2016

AUTHORIZING THE REALIGNMENT OF Php 2,807,857.05 IN THE CURRENT MUNICIPAL
BUDGET FROM PROJECTED SAVINGS (PERSONAL SERVICES & FINANCIAL ASSISTANCE)
TO PAYMENT OF TERMINAL LEAVE PAY AND GENERAL SERVICES

WHEREAS, presented to the Body for consideration is the letter of Honorable Mayor Jose Antonio T. Feliciano dated April 5, 2016 requesting for the realignment of Two Million Eight Hundred Seven Thousand Eight Hundred Fifty Seven Pesos and 5/100 to fund the terminal leave pay of the late Olivia P. Caluya and the recently resigned Ms. Rosabel Miclat as well as expenses for General Services;

WHEREAS, based on the Statement of Fund Available for Realignment dated April 1, 2016 which supports the said request, the realigned funds have been sourced from projected savings (Salary & other benefits of various vacant positions and appropriation for Financial Assistance) ;

WHEREAS, this Body is convinced that the said realignment is necessary and in accordance with budgetary rules and regulations;

NOW THEREFORE, on motion of Councilor Danilo L. Lugtu unanimously seconded:

BE IT RESOLVED, to authorize the realignment of Two Million Eight Hundred Seven Thousand Eight Hundred Fifty Seven Pesos and 5/100 (Php 2,807,857.05) in the current Municipal Budget from Projected Savings (Personal Services & Financial Assistance) to payment of Terminal Leave pay and for expenses under the General Services
