AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE BUSINESS FOR SOCIAL PROGRESS (PBSP), CLARK DEVELOPMENT CORPORATION (CDC) AND NATIONAL COMMISSION ON INDIGENOUS PEOPLES (NCIP-REGION III) FOR THE IMPLEMENTATION OF POTABLE WATER SUPPLY PROJECT AT SITIO SAN MARTIN, BARANGAY SAN VICENTE, THIS MUNICIPALITY

WHEREAS, presented for review and appropriate action was a Memorandum of Agreement (MOA) to be entered into by and between the Municipal Government of Bamban, Philippine Business for Social Progress (PBSP), Clark Development Corporation (CDC) and the National Commission on Indigenous Peoples (NCIP) for the implementation of a potable water supply project at Sitio San Martin, Barangay Sto. Nino, this Municipality;

WHEREAS, the Php1,134,093.00 potable water system project was designed by the PBSP and to be implemented and sustained in collaboration with the CDC, NCIP and the Municipal Government of Bamban ;

WHEREAS, this Body believes that potable water is a basic necessity in every community and once operational , Aeta communities in the area stand to benefit from the water system project;

NOW THEREFORE, on motion of Councilor Robin S. Mangiliman , unanimously seconded:
