RESOLUTION NO. 374, SERIES OF 2016

AUTHORIZING THE GRANT OF 2016 MID-YEAR BONUS TO OFFICIALS AND EMPLOYEES OF  
THE MUNICIPAL GOVERNMENT PURSUANT TO EXECUTIVE ORDER NO. 201,  
SERIES OF 2016

WHEREAS, pursuant to Executive Order No. 201, series of 2016 entitled, "Modifying the Salary Schedule for Civilian Government Personnel and Authorizing the Grant of Additional Benefits for Both Civilian and Military and Uniformed Personnel", the Department of Budget & Management on April 28, 2016 issued Budget Circular No. 2016-3 or the Rules and Regulations on the Grant of Mid-Year Bonus for FY 2016 ;

WHEREAS, said circular requires, among others, that the grant of Mid-Year Bonus to personnel of LGUs shall be determined by their respective sanggunian subject to certain considerations;

WHEREAS, the Sangguniang Bayan in anticipation of the said Executive Order had already appropriated the necessary budget in order to grant the said benefits to qualified officials and personnel of the LGU;
