RESOLUTION NO. 379, SERIES OF 2016

REFERRING TO THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO FOR APPROPRIATE
ACTION THE COMPLAINTS ON ILLEGAL OCCUPATION OF SIDEWALKS, AND CERTAIN
PUBLIC LANDS IN DAPDAP RESETTLEMENT AREA

WHEREAS, the president of the DapDap Homeowners Association (HOA) on this date approached the Sangguniang Bayan to verbally bring to its attention the illegal occupation of public areas in DapDap Resettlement such as the sidewalks, park/oval , etc. and suggested that if possible, the HOA be granted a sort of authority to order the removal or demolition of the existing structures in the identified areas and prevent any more similar structures to be built ;

WHEREAS, the Sangguniang Bayan is aware of these illegally put up structures but is also aware that there are already laws enacted primarily to address this kind of problem such as the National Building Code, Municipal Ordinance No. 09-2012 (Regulating the Use of roads, sidewalks and public plazas xxx)), thus, all that is needed is enforcement of the laws thru the Office of the Municipal Engineer;

NOW THEREFORE, on motion of Councilor Noel S. Rivera duly seconded:

BE IT RESOLVED, that acting on the said concern of Mr. Leonardo Policarpio, president of HOA , this Body hereby refer to the Honorable Mayor Jose Antonio T. Feliciano- thru the Office of the Municipal Engineer - for appropriate action in accordance with existing ordinances the cases of illegal structures/illegal occupation of sidewalks/public land in DapDap , among these are:

1. road shoulder at the back of DRES;
2. portion of the DapDap oval;
3. area fronting the Birthing Clinic ;
4. vacant lot near the Iglesia ni Cristo church
5. tiangge stalls on sidewalks leading to Guadalupe church

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and be furnished Engr. Jose L. Vital, Municipal Engineer, Mr. Leonardo Policarpio, HOA President, and others concerned, for their information and appropriate action.
