APPROVING THE GRANT OF ADDITIONAL ALLOWANCES TO THE MUNICIPAL BOARD
OF CANVASSERS (MBOC) AND THE SUPPORT STAFF WHO SERVED IN THE MAY 9,
2016 ELECTIONS IN ACCORDANCE WITH COMELEC EN BANC RESOLUTION NO. 07-
0626

WHEREAS, the Honorable Mayor in his letter to the Sangguniang Bayan requests that the grant of additional allowances to the Municipal Board of Canvassers (MBOC) and its support staff who served during the May 9, 2016 elections be approved ;

WHEREAS, the granting of additional allowances to the MBOC and its support staff by the local government unit – aside from the honoraria given by the Commission - is authorized under COMELEC En Banc Resolution No. 07-0626 but needs approval by the concerned sanggunian prior to its local implementation ;

WHEREAS, this Body is convinced that the MBOC and its support staff deserve additional allowances considering the gargantuan and delicate responsibilities that were assigned to them during the May 9, 2016 election

NOW THEREFORE, on motion of Councilor Danilo L. Lugtu, unanimously seconded:

BE IT RESOLVED, that the Sangguniang Bayan hereby approves the granting of additional allowances to the Municipal Board of Canvassers (MBOC) and its support staff who served during the May 9, 2016 election in accordance with the minimum flat rate authorized by the COMELEC, and that the amount be charged to the LGU's current appropriation for Election Expenses.
