RESOLUTION NO. 384, SERIES OF 2016

STRONGLY REMINDING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO STRICTLY
IMPLEMENT THE MUNICIPAL ORDINANCES PENALIZING MOTORISTS /DRIVERS WHOSE
MOTORCYCLES /TRICYCLES DO NOT HAVE WORKING MUFFLERS

WHEREAS, the unbearable, deafening noise caused by motorcycles with rigged exhaust systems or no working muffler has been a perennial complaint from the public and this is understandable because the annoying and unnecessary noise tend to disturb or violate peace;

WHEREAS, this particular nuisance, among other traffic problems had already been addressed with the enactment of Municipal Traffic Code (Municipal Ordinance No. 04-97 as amended) and Section 15 of Municipal Ordinance No. 10-2012 (Tricycles-For-Hire Regulatory Ordinance of 2012) , but apparently this particular traffic violation has not been strictly implemented or offenders duly penalized ;

WHEREAS, punong barangays have recently raised concern for the need to strictly apprehend the violators and have approached the Sangguniang Bayan to ensure that this problem be finally acted upon;

NOW THEREFORE, on motion of Councilor Reynaldo L. Pangilinan, Sr. unanimously seconded:

BE IT RESOLVED, that the Sangguniang Bayan in the exercise of its oversight power, hereby strongly remind the Honorable Mayor Jose Antonio T. Feliciano to strictly implement the aforementioned Municipal Ordinances specifically those providing for the apprehension and imposition of penalty to drivers /owners of tricycles/motorcycles without a working muffler or with rigged exhaust system, summarized as follows:

1. **Tricycles for Hire** - P300.00 (1st Offense); P350.00 (2nd Offense) Impoundment of Tricycle & permanent cancellation of franchise (#3rd & final offense)
2. **Other motorcycles** – P150.00 or imprisonment of five (5) days or both upon discretion of the court

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano for his information and appropriate action and be furnished all the punong barangays of this Municipality, PCI Jovy P. Arceo , PNP Chief, and all others concerned, for their information.
